We have been working with DHS and a diverse industry planning team to develop scenarios, and prepare for a great multi-day event in the first quarter of this year. We will be represented on the floor of Exercise Control located in the Washington. D.C area. As trusted agents, we keep the scenarios close to the vest so that valid after action reports and lessons learned might be obtained. Each Cyber Storm builds on lessons learned from previous real world incidents, ensuring that participants face more sophisticated and challenging exercises every two years.

The core thrust of Cyber Storm is to examine or validate organizational capacity to prepare and respond to incidents, strategic decision making, information sharing and situational awareness and means to disseminate sensitive information. NH-ISAC has partnered with Symphony to allow its members to securely communicate with each other in an easy to use system that offers both browser-based, and mobile solutions for communications. NH-ISAC member organizations will be able to log into a messaging service where they can create teams, share attachments, and discuss current events and issues they are seeing internally. Additionally, members will be able to pull in outside data from services such as Twitter, Dow Jones, and other information feeds, all with the knowledge that the data has been encrypted end to end.



FDA Medical Device Cybersecurity Workshop

The Food and Drug Administration (FDA), in collaboration with the National Health Information Sharing and Analysis Center (NH-ISAC), the Department of Health and Human Services (HHS), and the Department of Homeland Security (DHS) held a public workshop in Silver Spring, MD on January 20-21, 2016. The workshop, "Moving Forward: Collaborative Approaches to Medical Device Cybersecurity," brought together diverse stakeholders to discuss complex challenges in medical device cybersecurity that impact the medical device ecosystem. The purpose of the workshop was to highlight past collaborative efforts; increase awareness of existing frameworks leveraged for benchmarking an organization's processes used to evaluate cybersecurity status, standards, and tools in development; and to engage the multi-stakeholder community in focused discussions on unresolved gaps and challenges that have hampered progress in advancing medical device cybersecurity.
