Medical Device Vulnerability Intelligence Program for Evaluation and Response (MD-VIPER)

MD-VIPER is an NH-ISAC and MDISS initiative open to medical device security stakeholders. It is a vulnerability reporting program. The goal of MD-VIPER is to provide a medical device vulnerability sharing, evaluation, and response service; support FDA's Postmarket Management of Cybersecurity in Medical Devices final guidance; create an open community of medical device cybersecurity stakeholders (manufacturers, healthcare delivery organizations (HDOs), independent security researchers, regulatory agencies, etc.) to promote a consensus and consistency of vulnerability reporting and information sharing approach and process; contribute significantly to medical device cybersecurity education; and foster situational awareness of medical device threats, best practices and mitigation strategies.

NH-ISAC and MDISS held a webinar on Tuesday, January 31, 2017, for medical device stakeholders. The webinar had 165 attendees. The presentation along with the recording link will also be available on our website.
